Dear Governors.

Do only that which is authorized by Constitutions in order to serve your personal grace before your constituents and the Public Trust.

We Beneficiaries are speaking on behalf of all Americans because no one else will.

No one has bothered to identify the root issues and directly confront the People's public servants, apply the law to Governors and demand recognition that each of you is required to answer to the People for every act or omission done in the name of the People's Governments, specifically to the States United you each serve.

YOU WILL TAKE NOTICE: That this Writ of Quo Warranto, by what authority, is issued under Seal of a Sovereign American. This Sealed presentment is a Letter of Wishes from the Grantor, the Bailor of all government powers or authorities creating the Public Trusts, known as States, from the exclusive Beneficiaries position, addressing public servants acting in capacity of Trustee over the People's political powers and our law of Constitutions.

In the event you challenge the Seal or the authority it is based upon beginning 4 July, 1776, you will be challenging the Public Trusts you promised to serve, are paid to serve, which will be an open public record act of rebellion and sedition.

We the above identified Beneficiaries address you and each of you identified above as both individuals and a group. Beneficiaries are addressing all of you in the context of a jury making findings of fact and judgement of law.

Juries pass judgement. You all are going to judge yourselves by your own public record acts, and do so in front of your constituents that trusted you to be an honest public servant. Matters not that you choose to not participate in the People's Original Jurisdiction Writ of Quo Warranto, because your public acts one way or another are public records owned by the People, judgement of facts over government operations. More to the point none of you public servants from top, to bottom state or national, have any jurisdiction whatsoever over the People's Original Jurisdiction.

You and each of you identified above have already agreed to be subject of and to the People's Original Jurisdiction under our law of Constitutions. That's the first thing you each did when you got elected and then inaugurated. You all took the OATH! And, voluntarily so with no reservations whatsoever.

SPECIAL NOTE AS FAIR NOTICE AND OPPORTUNITY TO RESPOND.

Quotes from the Washington State law below are believed to be identical or relatively so in each of your states.

"RCW 42.56.030; Construction.

The people of this state do not yield their sovereignty to the agencies that serve them. The people, in delegating authority, do not give their public servants the right to decide what is good for the people to know and what is not good for them to know. The people insist on remaining informed so that they may maintain control over the instruments that they have created. This chapter shall be liberally construed, and its exemptions narrowly construed to promote this public policy and to assure that the public interest will be fully protected. In the event of conflict between the provisions of this chapter and any other act, the provisions of this chapter shall govern.”

This declaration defines who is who in the zoo. You all work for the People as servants and have no powers whatsoever to decide what our law of Constitutions means nor hide anything that affects the People from those you get paid and promised to serve.

“RCW 42.56.060; Disclaimer of public liability.

“No public agency, public official, public employee, or custodian shall be liable, nor shall a cause of action exist, for any loss or damage based upon the release of a public record if the public agency, public official, public employee, or custodian acted in good faith in attempting to comply with the provisions of this chapter.”

This declaration is the Sovereign Immunity you all like to claim. Protection by Sovereign powers of the People requires good faith. That means being honest and telling the truth all the time when you work for We the People.

This also means that when the well supported claims of vote theft through election fraud began to appear after November 4, 2020, and you did nothing, did nothing when Congress and the courts ignored mounting and rapidly accumulating evidence of theft of the People’s most precious property, our vote, then added insult to injury by identifying Joe Biden as President, you created public record that you supported swindling not only the People and State that allows you to serve, you ratified your lack of good faith, integrity, and trustworthiness.

More to the point you all joined a conspiracy through silence when you had a paid for duty to speak and act. The multi state, multi-jurisdictional multi event crimes rise to RICO under the fact that after crimes were known to you from multiple sources of competent public record, and you over and over referred to Joe Biden as President. Minimum predicates are met as is shown from your own public statements carried over interstate commerce jurisdictional lines.

No President could ever lawfully or legally pass the powers of the highest office of government in the land of America, the Presidency, to anyone claiming the People’s highest public office under cloud of fraud.

Any and all public servants, you all in particular, having higher knowledge and duties, when referring to Joe Biden as President, are actively participating in a conspiracy to defraud the nation as a whole, all the People, which qualifies you and each of you to be identified as an Enemy of the State.

SECOND SPECIAL NOTE, FAIR NOTICE AND OPPORTUNITY TO RESPOND.

One quote from good standing constitutionally compliant federal statutes wraps up your lack of good faith. No Chief Law Enforcement Officer could ever claim ignorance of the below.

“18 U.S. Code § 4 - Misprision of felony

Whoever, having knowledge of the actual commission of a felony cognizable by a court of the United States, conceals and does not as soon as possible make known the same to some judge or other person in civil or military authority under the United States, shall be fined under this title or imprisoned not more than three years, or both.”

BY WHAT AUTHORITY DO YOU OR ANY OF YOU CLAIM THAT INDICATIONS, EVEN OF THE VERY SMALLEST SORT, EXPOSING FRAUDULENT PRACTICES RELATED TO THE OPERATION OF THE 2020 ELECTION, DOES NOT REQUIRE FULL INVESTIGATION, and INVALIDATING FOR FRAUD THE TRANSFER OF THE PEOPLE'S POLITICAL WILL FROM PRIOR DULY ELECTED PUBLIC SERVANTS TO SOMEONE RELYING ON AN ELECTION TAINTED WITH THE SMELL OF FRAUD?

By What Authority could you or any of you ever claim you do not know fraud vitiates completely a transaction to which fraud is associated?

The People never granted jurisdiction to the governments We created, nor any public office nor public servant the power or authority to rule over or overrule the People's Law of Constitutions. Thus, the People's exercise over our public servants recognized by the properly identified People's Original Jurisdiction captures completely, each of you and the offices you serve.

As Governors, each of you are the Chief Law Enforcement Officer, a functioning Chief Magistrate, required by constitution to make findings of fact conclusions of law so that the law of the Constitutions, particularly the Declaration of Rights, will be properly recognized in order to protect the People. Law Enforcement for you all means the constitutions both your States and the United States Constitution, good standing constitutionally compliant statutes are the rule of decision. None of you, nor any other public servant, are granted discretion on which portion of the Constitutions you will recognize or enforce. Nor were any you granted discretion to not prosecute known wrong doers when the evidence of crimes is in every Americans, and particularly your face and now known worldwide. Nor were any of you granted the privilege to close your eyes to criminal acts, put political positions ahead of lawful duties, ignore evidence of the American voter being swindled out of our property identified as our votes.

This Quo Warranto issued from the People's Original Jurisdiction is a set up. You and each of you are the subjects of the set up. One way or another you all are going to show and tell the American People the answer to one question.

What side of the law do you stand on?

You all have two choices. Stand on the People's Law of Constitutions and good standing statutes requiring honest elections, or, identify yourself as supporting fraud, swindles, theft, operating in conspiracy to overthrow the legitimate governments that was operating prior to January 2021.

There is no question that the 2020 election was massively tampered with. Matters not the scale of a fraud. Once a fraud always a fraud. Even the faintest sniff of fraud voids a transaction, and everyone identified above knows it. An election is a transaction transferring the People's political power to the governments We created through well paid supervising service by you Governors.

The term Quo Warranto means by what authority. Being that the American People are Sovereign's over the governments We created and each of you are a voluntary public servant operating in public offices owned by the People, you all are subjects to the People's Original Jurisdiction. Thus, when the People, even one of us, issues the Writ of Quo Warranto, each one of you as duly served are required to answer with specificity.

BY WHAT AUTHORITY DO YOU OR ANY OF YOU REFUSE TO ACT TO ENSURE THE ELECTIONS PROCESS CARRIED OUT UNDER YOUR WATCH ACTUALLY PLACES THE INDIVIDUALS IN PUBLIC OFFICE THAT WERE CHOSEN BY THE PEOPLE UNDER AN HONEST ELECTION?

Every individual identified above in both personal and official capacities is now faced with the choice to exercise your own Grace and seek Redemption from your constituents! OR. Pass judgement on your selves on open public record in front of all the People living in the State you serve.

Pre-Apology is presented by Beneficiaries to those Governors who have held to the principles, facts and laws of the People. You know who you are. Beneficiaries are offering the opportunity to rise to the next level. The one above political rhetoric and positioning. That rise to straight up truth based on open public record facts is also a choice you and each of you must make on your own.

LETTER OF WISHES and LETTER OF ADVICE.

Letter of Wishes from Beneficiary to the Trustee to the People's Public Trust you and each of you serve.

YOU WILL PLEASE: Take the following actions in a timely manner.

1. Personally contact President Trump to extend your apology for failing to identify the FRAUD, THEFT, ABUSE OF PUBLIC OFFICE, REBELLION and INSURRECTION associated with the 2020 election process that caused President Trump to be perceived by the People as the former President.
2. Issue a public apology to your constituents for failing to recognize in a timely manner that no elected public officer, particularly a President, could ever be ousted from elected office, could ever lawfully transfer official powers to another public servant when the merest hint of FRAUD taints an election processing in the States United.  - A. Exercise the Chief Magistrates powers, attendant to the Office of Governor as the Chief of Law Enforcement in your State, to make findings of fact conclusions of law that the 2020 election is void for FRAUD.
 - B. Craft a joint statement declaring the 2020 election VOID. Issue the joint statement the same day timed to take advantage of media cycles. Reference in the statement that all acts by those elected under the 2020 election are voidable.
 - C. Advise in official writing, every public servant serving the People of your State, relying on the 2020 election for their position, that all acts taken under tainted assumption of public office are voidable as are all supervisory acts over government functions and agencies.
 - D. Advise Joe Biden and Kamala Harris, in formal writing from the Governor's Office of your State, that each and every act taken while operating as President and President of the Vice, are voidable and each will be held fully accountable for failing to ensure their assumption to the People's public offices was accomplished under honest elections process.

In the strongest terms possible advise, Beneficiaries Letter of Wishes issued by the State, that the United States Government was created as a servant to the States United.

Recognize in your statement that when the People demand BY WHAT AUTHORITY the public servant is required to answer by law and provide all relevant facts and law supporting their acts in order to verify compliance with the Constitutions, particularly the Declaration of Rights and the national Bill of Rights.

Recognize in your statement that when the People demand BY WHAT AUTHORITY they are taking care of the personal vote property and inviting their public servants to assist in that care. True partnership!

The Court of Public Opinion is in session collecting evidence. The Court of Public Opinion includes every public servant from top to bottom, particularly those having


evidence of individuals serving corruption of government process while taking a paycheck promising to serve the principles of our American Dream under the law set out by the People.
